**Event Information**: Campbell United Methodist Church is hosting the 3<sup>rd</sup> annual **Run for the Son.** The 10k, 5k and the one mile run/walk will all start at 8:00 a.m. across the street from CUMC at First Cumberland Presbyterian Church. The races are preceding a <u>FREE children's Easter</u> event that will take place at 10:00 a.m. at the back field of Campbell UMC. Proceeds from the run will provide for Campbell UMC Small Wonders, Schweitzer UMC Grow to Know and Wesley UMC Kids of Creation to better serve the children in our community. Each paid participant will receive a race shirt if you signup before April 3rd. <u>Receiving a shirt after April</u> 3rd will depend on the number of shirts still available.

Awards: 1 mile run/walk - Medals will be given to the top male and female 19 and under and top male and female 20+.

5k and 10k run/walk - Medals will be given to the top male and female overall and male and female masters. Medals will also be given to the top 3 in each age group: 19 and under, 20-29, 30-39, 40-49, 50-59 & 60+

**Location:** All runners should park in the Campbell UMC parking lot. The race will start across the street from Campbell UMC and travel through the Ravenwood housing area. Thank you to First Cumberland Presbyterian Church for providing a safe starting point for our race. Everyone **must** use the crosswalk to cross Republic road from CUMC to First Cumberland Presbyterian.

**Race Fee:** 10K early registration \$35 or \$40 on 4/15/17 5K early registration \$25 or \$30 on 4/15/17

**1mile** early registration \$15 or \$20 on 4/15/17

**Family/Friend Discount: MAIL IN ONLY** (NOT AVAILABLE ONLINE) Every 2 participants from any race distance who register together will= \$5.00 total discount until 4/14/17 (example: two 5k register together = \$45 total or one 10k and one 5k register together = \$55 total, etc...)

Packet Pickup: Friday, April 14th from 3:30 pm-6pm at Campbell UMC & the morning of the race from 7:00 a.m. -7:45a.m.

Waiver: I understand running is a potentially hazardous activity. I should not enter and participate unless I am physically fit, mentally able and properly trained. I agree to abide by any decision of the race officials relative to my ability to safely complete the run. I certify I am in good health and properly trained to run the distance of this race. I assume all risks associated with running in this event, all risks being known and being appreciated by me. I understand my entry fee is non-refundable.
